

## **TOWN OF WELLS MINUTES FOR FEBRUARY 9<sup>TH</sup>, 2023 MEETING**

The board for the Town of Wells held their monthly board meeting on Thursday, February 9<sup>th</sup>, 2023 at the town hall. The meeting was properly posted and published. The meeting was called to order at 7:05 p.m. by Supervisor Greg Schmitz as the chairman, Dennis Hemmersbach was absent. Supervisor Jeff Schmitz and Clerk Diane Schwarz and Treasurer Simon Wells were all present.

The minutes were reviewed for the Caucus meeting on January 12<sup>th</sup>, 2023. Jeff Schmitz made a motion to approve the minutes as read. Greg Schmitz seconded the motion. Motion carried. Motion carried. Simon Wells gave the treasurer's report. There was a question about a deposit of \$2,811.37. It was questioned whether it was a DOT payment or something else. It will be checked into. The expenses for January-February 2023 were reviewed. Greg Schmitz made a motion to pay the bills. Jeff Schmitz seconded the motion. Motion carried.

The contribution of \$1,500.00 was given to the town by a resident of the town was discussed. There has been discussion earlier in past meetings of what the town would most benefit from. There was some discussion about replacing the flooring of the townhall as you could observe that the flooring was deteriorating. After checking into information that is needed to make an informed decision and about the costs of removal and replacement of the flooring, Greg Schmitz made a motion to use the monies that were contributed to the town to be used to replace the flooring in the townhall. Jeff Schmitz seconded the motion. Motion carried. A note of thanks will be sent to the contributor of the gift.

There was a question on whether the skid steer is covered by insurance. It will be checked into.
