

## **TOWN OF WELLS MINUTES FOR SEPTEMBER 8<sup>TH</sup>, 2022**

The board for the Town of Wells held their monthly board meeting on Tuesday, September 8<sup>th</sup>, 2022 at the town hall. The meeting was called to order by Chairman Dennis Hemmersbach at 7:30 p.m. The meeting had been properly posted and published. Supervisors Jeff Schmitz and Greg Schmitz were present as well as Treasurer Simon Wells and Clerk Diane Schwarz. The minutes were reviewed for August 18<sup>th</sup>, 2022. Greg Schmitz made a motion to approve the minutes as read. Jeff Schmitz seconded the motion. Motion carried. Simon Wells gave the treasurer's report. Greg Schmitz made a motion to approve the report. Jeff Schmitz seconded the motion. Motion carried. The expenses were reviewed for September. Greg Schmitz made a motion to pay the bills. Jeff Schmitz seconded the motion. Motion carried. There was no public input.

The matter of applying for grants through the USDA was discussed. The clerk will look into the grant application and provide the information needed to apply.

The Large Item Garbage Collection weekend for the fall has been scheduled for Friday, October 7<sup>th</sup> and Saturday, October 8<sup>th</sup>, 2022. The board will check into scheduling the workers for the weekend event. The WTA Fall Budget District meetings will be in September. The board will attend if possible or will possibly watch the webinars that are offered.

Updates on roads and equipment was discussed. There have not been applicants for the patrolman position, yet. The town roads will need maintenance of brush and weed cutting. Ditching of some town roads will have to be made. The board will survey which roads need maintenance done on the roadways and ditching. Lake Road, Janus and Kapok, Jasper Road and Keyway Roads will need some kind of maintenance as well as some culvert maintenance if not this year, next year. Greg Schmitz will check over the roads and hire Brooks Excavating, if possible to complete some of the tasks. Khaki Road needs a culvert replaced but the road is shared with Town of Ridgeville for maybe next year.

The Budget Planning meeting is scheduled for Monday, October 10<sup>th</sup>, 2022 at 9:30 p.m. The regular monthly meeting is scheduled for Thursday, October 13<sup>th</sup>, 2022 at 7:30 p.m.

The matter of the surveying job by Gary Sime was discussed. The clerk will let Gary Sime and the lawyer Penny Precour that the job will need to be completed by the next meeting date of October 13<sup>th</sup>, 2022.

Greg Schmitz made a motion to adjourn the meeting. Jeff Schmitz seconded the motion. Motion carried. The meeting adjourned at 8:26 p.m.
