TOWN OF WELLS MINUTES FOR AUGUST 18TH, 2022

The board for the Town of Wells held their monthly board meeting on Thursday, August 18th, 2022. The meeting had been rescheduled due to illness of board members. A note will be emailed to Gary Sime to urge him to complete the information needed to complete the survey which should include the Rengert, Danielson, Gatzke and Ollendick properties.

It has been confirmed by Jeff Schmitz that the driveway by Loren Whitehead had been finished but Jeff indicated that it really wasn't going to fix the problem but is okay for now.

Updates on roads and equipment was discussed. The roads that had selected to be seal coated had been completed. Dennis thought that they look in good shape. * It was indicated that a section of road along Jancing Avenue needs to be filled in with some gravel along the blacktop from runoffs of heavy rain. Jasper Road also needs to have a hole filled. * The town is still looking for a patrolman and trying to recruit for help.

The Large Item Collection Weekend is scheduled for Friday, October 7^{th} , 2022 and Saturday October 8^{th} , 2022 from 8 A.M. – 3 P.M. The next board meeting is scheduled for Thursday, September 8^{th} , 2022.
