## MINUTES FOR APRIL 14<sup>TH</sup>, 2022

The board for the Town of Wells held their monthly board meeting on Thursday, April 14th, 2022. The meeting was called to order by Chairman Dennis Hemmersbach at 7:30 p.m. The meeting was properly posted and published. Supervisors Greg Schmitz and Jeff Schmitz were present as well as Treasurer Simon Wells and Clerk Diane Schwarz. There were 21 people present at the meeting.

After some discussion, Greg Schmitz made a motion to approve the transfer of the liquor license from Annettra Muehlenkamp to Matt Schaitel for the Alchemy Brew Pub. Jeff Schmitz seconded the motion. Motion carried. The liquor license application will have to be approved again in June.

The board scheduled a WISLR road review of the town's roads for April 20<sup>th</sup>, 2022 and also a review of the sites of the Archery/Clubhouse application by Kyle Schmitz.

The board has requested to put another want ad into the paper for the need for a patrolman. There were no updates on roads and equipment noted. The Annual meeting is scheduled for April 18<sup>th</sup>, 2022 at 7 p.m. The next board meeting will be scheduled for Thursday, May 12<sup>th</sup>, 2022 at 7:30 p.m.

Jeff Schmitz made a motion to adjourn the meeting. Greg Schmitz seconded the motion. Motion carried. The meeting adjourned at 9:30 p.m.
